Anatomy of a Motorcycle Sidestand Defect Case



NWARRANTED ATTACKS on trial lawyers come from a lack of understanding the difference we make in improving public safety. Barroso v. City of Coral Gables - \$1 million Civil Rights Violation

Case No. 94-0457, S.D. Fla.

Alvin Barroso was planning to go to law school. On the night of his death he was studying for the LSAT exam. Alvin and his twin brother owned a small business where they often studied late at night.

A recently fired employee had broken into the office causing the brothers to take turns staying at the office. They contacted the police who placed a "watch order" on the office. Two rookie officers. aware of the watch order, saw a light go out in the office while they drove by. Instead of calling the office or having a supervisor join them, they began an armed building search without announcing themselves. Alvin walked into the hallway to see what was happening. One of the officers fired two shots at him without warning, striking and killing him.

LLR partners **Ira Leesfield** and **John Leighton** assisted the family in a federal civil rights wrongful death suit against the

City for its defective policies and procedures. The City was aware that the procedures for watch orders were inadequate, and failed to properly train police officers in how to handle these situations. Counsel proved that the building search was improperly conducted, and that by failing to identify themselves as police officers it was reasonable that the victim could have thought this was a burglary in progress.

The City agreed to pay \$1 million. More importantly, procedures changed, including watch order and building search rules. Thanks to the Barrosos, Florida families are now safer!

Eimers v. Honda -\$19.8 million Verdict

Twenty-seven year old Todd Eimers was rendered a high level quadriplegic from a defective Honda motorcycle sidestand. From the time of his accident through verdict Todd barely survived on social security benefits. He was wheelchair bound, receiving only minimum life care. Following Todd's \$19.8 million dollar verdict, he obtained a motorized van, a computer, a handicapped adapted home and just recently was married. "His health is good, his outlook is bright and his life is enriched," according to Ira Leesfield. (Importantly the sidestand defect causing Todd's injuries has been eliminated by Honda and no similar accidents have been reported since the re-design of the sidestand.)

Rubio v. State Farm Fire & Casualty (David v. Goliath)

"This case is too small to litigate." How many times have you heard that? The Rubios had a small property damage claim when

their home was burglarized. Seven months later the carrier had not investigated or paid the claim. Insurance companies often believe they can wear down consumers through delay and unreasonable demands for information. Maria Rubio established a consumer's remedy for first party benefits under the Florida Civil Remedy Statute. The Third District Court ruled "compensatory damages are recoverable pursuant to statute including all damages reasonably foreseeable as a result of the violation, attorneys' fees and costs, and punitive damages." 662 So. 2d 956. This result made a big difference to the Rubios and all other policyholders whose "small claims" have been ignored.

Lynn v. Mt. Sinai Hospital

"It's your name and your reputation, I don't want to lose it." Tongala Lynn supports two small children and had a perfect work record with The **Dade County Corrections** Department. During a routine urinalysis her sample was mixed up with a male who was cocaine positive. She lost her job for three years and fourteen days. **LLR's George Mahfood** turned all of that around. The Third District Court ruled that "the Court cannot allow hospitals to use medical malpractice as a convenient shield for all the torts ..., "22 FLW D1119a.

Tongala Lynn is back to work and in Court where justice will be served. Her case matters not only to her young children but the community who recognizes the value of one's reputation.

- **3. The Wreckers Museum.** Key West was one of the richest cities per capita in the United States at the turn of the century. The shipping industry was thriving and so were the wreckers. Wreckers were ship salvagers who would salvage the goods from ships that ran afoul off of the dangerous waters of Key West. Their history is featured in the Wreckers Museum on Duval Street, located in a 167 year old house, the oldest in the keys. It's a must see!



Anatomy of a Motorcycle Sidestand Defect Case

OTORCYCLE sidestand defect cases have recurring elements that reliably establish the responsibility of the manufacturer. Here are the highlights:

- The sidestand is not equipped with an electric interlock, an automatic or mechanical retraction device, nor any audible or visual warning that the rider has forgotten to retract.
- The sidestand is designed to extend and rest with a slightly forward angle.
- The sidestand is equipped with springs designed to hold the sidestand in the forward angle.
- The sidestand is mounted on the left side of the motorcycle.



- The extended sidestand does not retract in a left-hand curve.
- The extended sidestand prevents the motorcycle from achieving a sufficient lean to allow negotiation of the left-hand curve.
- The steel foot of the sidestand scrapes along the road surface and leaves a straight line scrape mark or discoloration in the pavement.
- The motorcycle leaves the roadway on the right side.
- The steel foot of the sidestand has fresh, deep abrasions from its high speed, high heat impact with the aggregate in the road pavement.
- Tragically, the rider is seriously injured or killed by an off road impact.
