

# Federal Judge Awards \$2.95 Million in Wrongful Death Drowning Cases

"Ivan Grayson, tormented by the mind numbing horror of the tragedy that wiped his family from the face of the earth, desperately needs to know why this happened."



— U.S. District Judge James Lawrence King 748 F.Supp. 854

In a landmark Federal Torts Claims Act opinion, Judge James Lawrence King awarded Ivan Grayson \$2.95 million for the loss of his wife and two young daughters resulting from the Navy's failure to maintain its pier in a safe condition. **LLR** partner **Ira Leesfield** was lead counsel. The Court noted that Mr. Grayson was a "loving father of his two daughters, age 18 months and

3 years old" and that "he cared immeasurably for them. "Following the reasoning in *Williams v. United States*, 681 F.Supp. 763, Judge King found the analysis of the *Williams*' Court to be of

particular help in ascertaining the trend of damage awards which allowed the compilation of similar Florida wrongful death actions involving deceased minor children and determined the average award in Florida to be approxi-

mately \$900,000 for a parent who suffered the loss of a young minor child. See also; *Johnson v. United States*, 780 F.2d 902, 908 (11th Cir. 1986) awarded \$1.8 million dollars for the parents of the young minor child.

**Leesfield** submitted a compilation of 19 wrongful death verdicts and settlements from Courts in South Florida upon which Judge King based his findings.

The Court likewise received testimony from a grief counselor on the issue of the survivors' loss of companionship, pain and suffering. (See Website Insert, Page 2.)
