mother. Just prior, Maria resolved a \$575,000 wrongful death auto award for the death of a 37 year-old man. Meanwhile, nursing home advocates John Leighton and Tom Scolaro achieved a \$600,000 settlement for 88 year-old Amelia Sanchez who was severely neglected and abandoned at the nursing home, causing her to sustain two separate hip fractures, both requiring complete hip replacements and extensive rehabilitation.
